## Stationing of USFJ-related Cost (¥572.8 billion/\$7.16 bn. ①+②+③+④)

- Cost for taking measures to improve a living environment in the surrounding areas of the USFJ facilities ¥57.1 billion

- Relocation ¥ 0.5 billion
- Other Cost (Compensation for fishery, etc) ¥25.5 billion

Notes: 1. Training relocation cost under the Special Measures Agreement extends into the SACO-related cost and the Realignment-related cost.

2. The SACO-related cost aims for implementation of the SACO Final Report to reduce burdens on Okinawa people, and the Realignment-related cost aims for contribution to reducing burdens on local communities of the Realignment initiatives. Since the cost sharing for the stationing of USFJ is made out of voluntary efforts to bear some costs in light of the importance to ensure the smooth and effective implementation of the Japan-U.S. Security Arrangements, its nature is different from the SACO and Realignment related costs, and therefore they are categorized separately.

3. The stationing of USFJ-related cost includes the MOD-related budget, other Ministries-related budget and the estimated (=non-budgetary) cost.
