

# Application Procedures for Multiple Visa for holders of HKSAR Document of Identity for Visa purpose (HKDI) or Macau Travel Permit

The following is an outline of application procedures for holders of Document of Identity for Visa purpose issued by the HKSAR (HKDI) and Macau Travel Permit issued by the Macau SAR who wish to apply for a multiple entry visa as a temporary visitor (period of stay: 90 days/entry, visa validity: max. 3 years). The visa is for the purpose of tourism, business affairs, and visits to relatives/acquaintances, so it is not permitted to perform activities to undertake revenue generating business operations or activities to receive remuneration.

## 1. Eligibility for Applicant

Holders of HKDI and Macau Travel Permit (**limited to those whose nationality is stated as “CHINESE” on the identification page**) with ordinary MRP (Machine Readable Passport)/ e-passport in compliance with the ICAO (International Civil Aviation Organization) standard, who wishes to apply for a multiple entry visa and are applicable to one of the following categories:

- (1) Individual who has travel record as temporary visitor to Japan in the last three years and has financial capacity to pay the travel expense
- (2) Individual with sufficient financial capacity
- (3) Spouse or children of the individuals who are mentioned (2) above

## 2. Necessary Documents to Submit

### **(1) Applicant with travel record to Japan in the last three years (as mentioned 1(1) above)**

- a. Application form (with Photo)
- b. HKDI / Macau Travel Permit (MRP/ e-passport in compliance with the ICAO standard only)
- c. Current or old HKDI / Macau Travel Permit that shows temporary visitor visa and entry stamp of Japan in the last three years
- d. Applicant's income tax return (certificate of deposit balance is also acceptable)
- e. A letter stating that the applicant wishes to apply for a multiple entry visa

### **(2) Applicant with sufficient financial capacity (as mentioned 1(2) above)**

- a. Application form (with Photo)
- b. HKDI / Macau Travel Permit (MRP/ e-passport in compliance with the ICAO standard only)
- c. Applicant's income tax return to prove the sufficient financial capacity (if necessary, documents such as certificate of deposit balance, stock dividend, pension, retirement allowance, inheritance, lease agreement, real estate register, deed of property, etc. are also acceptable)
- d. A letter stating that the applicant wishes to apply for a multiple entry visa

### **(3) Spouse or children of the individuals who are mentioned (2) above (as mentioned 1(3) above)**

- a. Application form (with Photo)
- b. HKDI / Macau Travel Permit (MRP/ e-passport in compliance with the ICAO standard only)
- c. Documents to prove kinship (marriage/birth certificate)
- d. (if applying separately from the applicant 2(2) above) documents of c as mentioned 2(2) above
- e. A letter stating that the applicant wishes to apply for a multiple entry visa

**If necessary, we might ask for additional documents apart from the documents mentioned above.**

\* These visas are applicable for residents of mainland China, Hong Kong and Macau, and the application of visas can be accepted only at the Embassy or Consulate-General of Japan covering applicant's residence. Please note that we may issue a single entry visa after visa examination.
