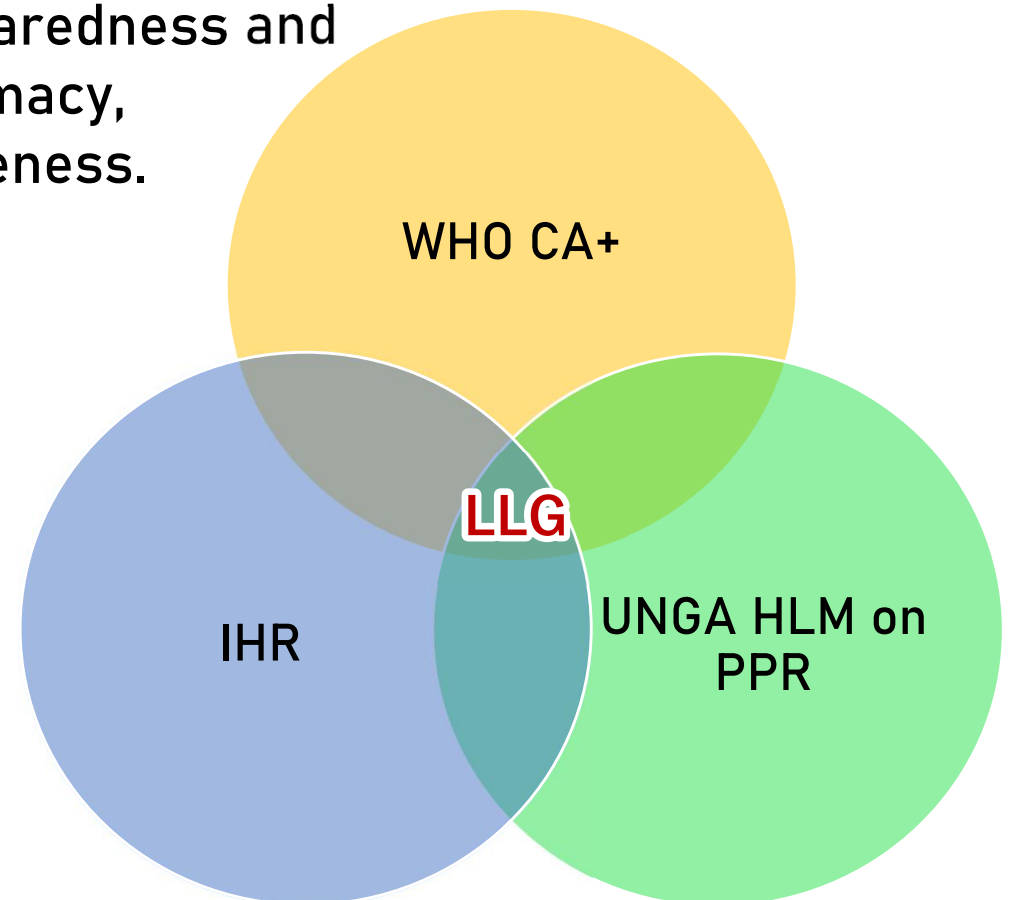




1. Developing and strengthening GHA

Governance

- ✓ The G7 commits to further enhancing political momentum toward **more coordinated and sustained leader-level governance (LLG)** for health emergency prevention, preparedness and response (PPR) that ensures legitimacy, representation, equity, and effectiveness.





1. Developing and strengthening GHA

Governance

The G7 Hiroshima Leaders' Communiqué

*“We commit to further enhancing political momentum toward **more coordinated and sustained leader-level governance for health emergency prevention, preparedness and response (PPR) that ensures legitimacy, representation, equity, and effectiveness**, noting the ongoing discussions including on a new instrument on pandemic PPR (WHO CA+), targeted amendments to the International Health Regulations (IHR), and the UN General Assembly (UNGA) High-Level Meeting (HLM) on pandemic PPR in September 2023 and the need to avoid duplication and ensure coherence between these processes, stressing the leading role of WHO.”*

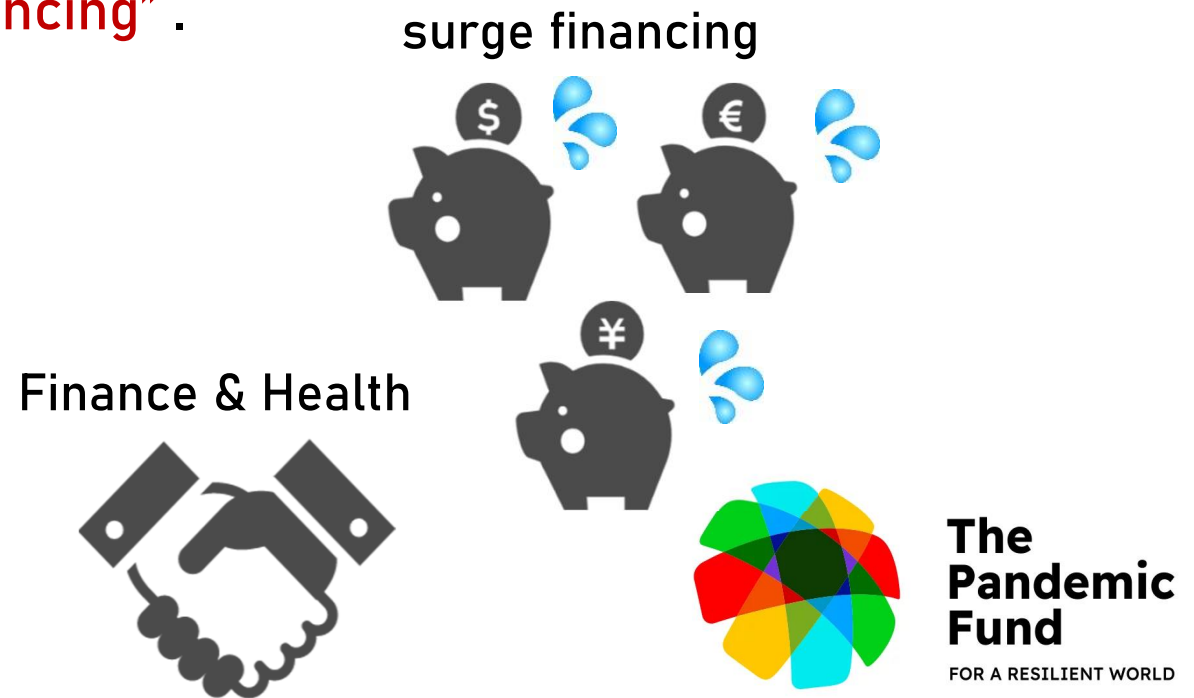
*“We call for enhancing political engagement towards **a more coordinated, sustained and stronger governance at all levels that ensures legitimacy, prioritisation and effectiveness through science-based decision making as well as equity and representation for all countries**, noting the upcoming United Nations General Assembly (UNGA) High-Level Meeting (HLM) on pandemic PPR in September 2023.”*



1. Developing and strengthening GHA

Finance

- ✓ The G7 commits to further promoting financial initiatives such as collaboration between Finance and Health Ministries, the Pandemic Fund, surge financing based on **the “G7 Shared Understanding on Enhanced Finance-Health Coordination and PPR Financing”**.





1. Developing and strengthening GHA

International Norms and Regulations

- ✓ The G7 commits to contributing and sustaining momentum on **the negotiations of the WHO CA+** and targeted amendments to the IHR, guided by equity and together with all stakeholders.



Human Resources for Health

- ✓ The G7 commits to strengthening and maintaining **sufficient and high-quality human resources for health worldwide at all times**, such as the public health and emergency workforce including consideration of Global Health Emergency Corps.





2. Achieving more equitable, resilient, sustainable UHC

Response to various health challenges

- ✓ The G7 will address **various health challenges significantly set back by the pandemic**, reaffirming the essential role of UHC.
 - ◆ Infectious diseases
 - ✓ HIV/AIDS, TB, Malaria
 - ✓ Neglected tropical diseases (NTDs)
 - ✓ Polio etc.
 - ◆ Non-communicable diseases (NCDs) etc.
 - ✓ Mental health conditions
 - ✓ Nutrition
 - ✓ WASH etc.
 - ◆ Life course challenges
 - ✓ Maternal and child health
 - ✓ SRHR
 - ✓ Healthy ageing
 - ◆ Antimicrobial resistance (AMR)

2. Achieving more equitable, resilient, sustainable UHC

G7's public-private financial contributions

- ✓ The G7 highlighted **its public-private financial contributions totaling more than \$ 48 billion** and call for further domestic resource mobilisation and private investment in order to contribute to global health including to the achievement of UHC.

*“The leaders of the participating countries and international organizations confirmed solidarity on global health to prepare for future health emergencies. **Japan highlights its \$7.5 billion public-private financial contributions** as part of the G7’s contributions.”*

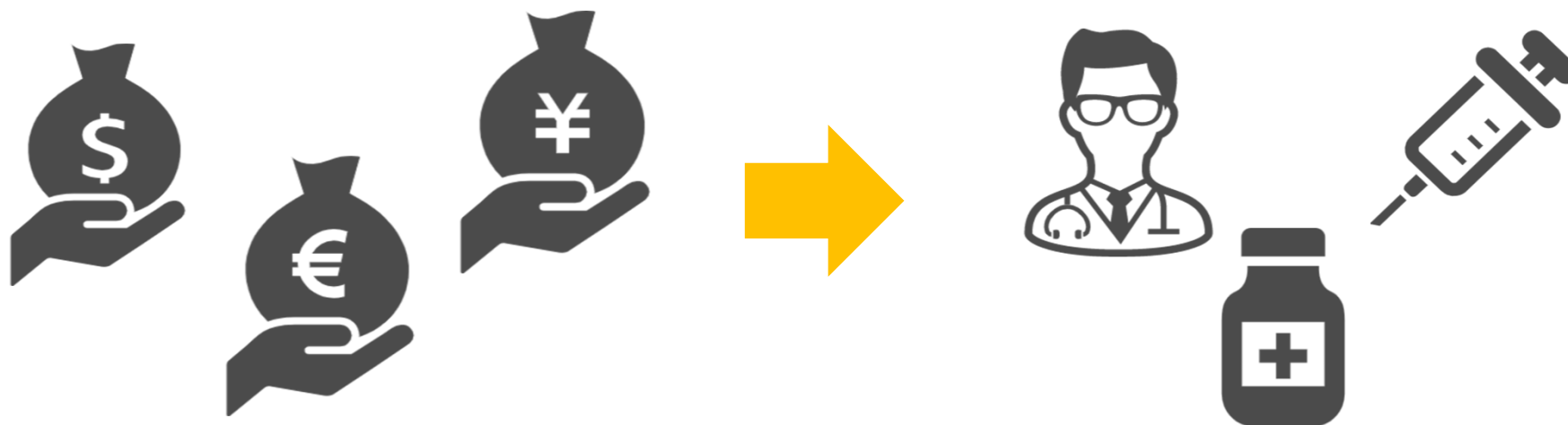

The “Triple I for Global Health”

- ✓ The G7 endorse **the “Triple I for Global Health”** to encourage impact investment in global health.



The “G7 Global Plan for UHC Action Agenda”

- ✓ The G7 released **the “G7 Global Plan for UHC Action Agenda”** and noted the importance of a global hub function, including for financing, knowledge management, and human resources on UHC.



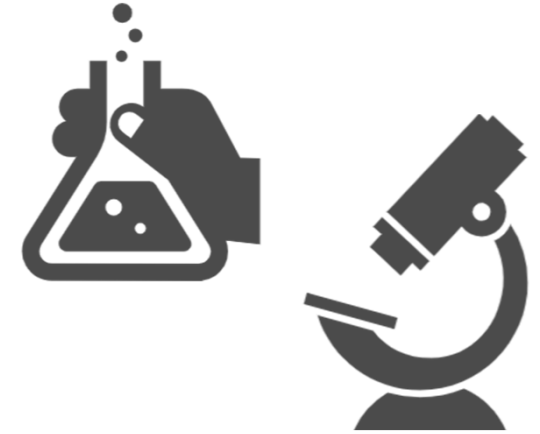

Promoting Health Innovations

Promoting R&D to respond to pandemics

- ✓ The G7 commits to promote **R&D to respond to pandemics including “the silent pandemic” of AMR** and implement pull and push incentives to accelerate R&D of antimicrobials with a view to the UNGA HLM on AMR in 2024.



Ensuring more equitable access to Medical countermeasures (MCMs)

- ✓ The G7 announced **the “G7 Hiroshima Vision for Equitable Access to Medical Countermeasures (MCMs)”** and launched the **“MCM Delivery Partnership for Equitable Access (MCDP)”** based on the Hiroshima Vision’s principles.

The Hiroshima Vision’s principles:

- ◆ *Equity*
- ◆ *Inclusivity*
- ◆ *Efficiency*
- ◆ *Affordability*
- ◆ *Quality*
- ◆ *Accountability*
- ◆ *Agility*
- ◆ *Speed*

Enhancing Equitable Access to MCMs : G7's Efforts and Way Forward with Partners



G7 Health outcomes (Hiroshima Summit and Health Ministers Meeting in Nagasaki)

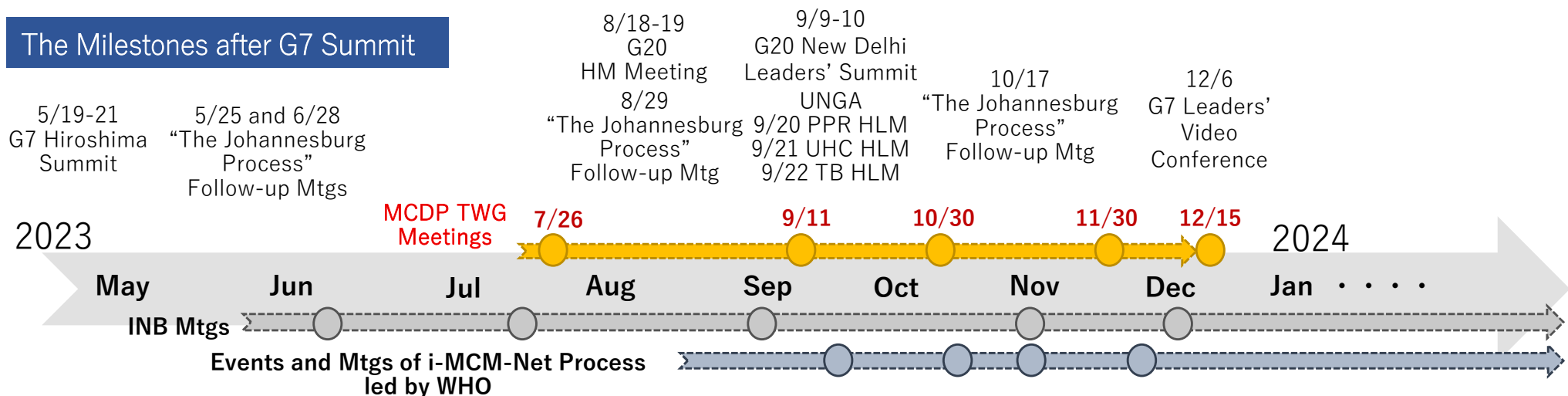
◆ To address health challenges by promoting health innovation, the G7 announced the **“G7 Hiroshima Vision for Equitable Access to Medical Countermeasures (MCMs).”** as a related document to the Leaders' Communiqué.

- The G7 members confirm their commitment to work towards equitable access to medical countermeasures (MCMs) for health emergencies.
- The G7 members support further discussions at the World Health Assembly, United Nations General Assembly, G20, WHO CA+, among other relevant forums, leading to concrete actions to facilitate equitable access to MCMs through strengthening the end-to-end global ecosystem. Drawing on relevant discussions and consultations with multiple stakeholders, we strive to promote guiding principles that should include: 1. Equity, 2. Inclusivity, 3. Efficiency, 4. Affordability, 5. Quality, 6. Accountability, 7. Agility, 8. Speed
- Together, we support a sustainable and equitable future, and commit to work together and with a range of partners to realize this vision for equitable access to MCMs in pandemics.

◆ In addition, the G7 announced the launch of the **“MCM Delivery Partnership for equitable access (MCDP)”** based on the principles set out in the “G7 Hiroshima Vision” and called on the participating countries and organizations to cooperate with the partnership.

- G7 members and relevant international organizations including WHO and UNICEF had cooperated to draft **MCDP concept note** to serve as a basis for further discussions and elaboration after the G7 Summit.
- Based on the draft MCDP concept note, TOR for MCDP Working Group was developed and the temporary WG (TWG) was launched in July. Since July, five meetings of the TWG have been convened.
- As deliverables of the TWG, two Issue Papers have developed closely coordinating with the TWG members and partners including WHO, UNICEF and Gavi. MCDP is expected to inform and inspire relevant ongoing global processes such as i-MCM-Net and INB.

Overview of the G7 Health Outcomes

Building on lessons from the COVID-19 pandemic, which has unprecedentedly affected not only people’s health but also the global community, economy and security, the G7 commit to (i) **developing and strengthening GHA**, to (ii) **contributing to achieving UHC**, and to (iii) **promoting health innovation**. **The G7 demonstrate their united determination and actions to contribute to global health.**

- ✓ Enhance political momentum toward **leader-level governance**
- ✓ Promote financing initiatives such as collaboration between Finance and Health Ministries, the Pandemic Fund, surge financing

- ✓ Strengthen and maintain **sufficient and high-quality human resources for health**
