Subject: Acceptance Letter of Japan's Contribution for the Supplementary Budget Projects

Dear Ambassador Nakashima,

I hereby would like to inform you the following, in reference to the letter dated 04 April 2024, concerning the Japanese contribution of thirty-five million and three-hundred ten thousand and eighty-seven US dollars (US\$35,310,087) to UNRWA for the execution of its projects listed in the Attachment (hereinafter referred to as the "Projects").

UNRWA wishes to thank the Government of Japan for its generous offer and confirms its acceptance.

UNRWA will assure that:

- (1) The Grant and its accrued interest will be used immediately, appropriately, and exclusively for the Projects, will not be used for military purposes, and will be administered in accordance with its regulations, rules, directives and procedures.
- (2) All necessary efforts will be made to publicize Japanese contributions through, for example, the issuance of a press release or organising launching ceremonies.
- (3) A letter to inform the completion of the Projects, as well as a report in the form of the Report of the Commissioner-General will be submitted to the Diplomatic Establishments of Japan concerned.
- (4) The Government of Japan and UNRWA will consult each other in respect of any matter that may arise from or in connection with the Grant.
- (5) After the completion of the Projects, the unused balance of Japan's Grant and its accrued interest will be refunded to the Government of Japan as soon as possible.

Furthermore, in accordance with the agreement between Commissioner-General of UNRWA and Minister of Foreign Affairs of Japan on March 28, 2024, UNRWA confirms its commitments with the Government of Japan as follows:

- (6) A new "Japan-UNRWA Project Management and Monitoring Mechanism" will be established to monitor the progress of assistance, to ensure the transparency and traceability of fund flows, and to assess the impact of the assistance on its targeted beneficiaries.
- (7) For the projects funded by Japan, all funds are transferred through financial institutions, and those institutions vet the recipients and beneficiaries against the international sanction lists, including that of the U.S. In case matches are found,

- (8) UNRWA will promote the participation of female staff as leaders in UNRWA's efforts for its governance reform and reconstruction of Gaza. Reflecting the concept of WPS in the programme, UNRWA will develop a training programme for the senior management level area staff like front-line managers and supervisors, to foster and strengthen accountability and compliance with the emphasis on integrity, neutrality and effective management practices, to be supported as a project funded by the FY2023 supplementary budget.
- (9) UNRWA will report on its activities to implement these commitments and Japan and UNRWA will consult on any necessary follow-up action through the mechanism referred to in paragraph 1 above. Further to such consultations, in case of inappropriate use of Japanese contributions, Japan reserves its rights within the terms of the contribution agreement to take all necessary measures to ensure the sound financial management of Japanese contributions to UNRWA.
