## IV. The Financial Burden on the Japanese Government.

The annual financial burden the Japanese government will have to bear under the above formula will be the sum remaining after deducting \$3,788,000 from \$15,036,205—namely, \$11,248,205. Of this amount, \$8,905,005 (¥3,205,801,800) represents expenditures in the Yen currency, and \$2,343,200 accounts for the cost of the coking coal for steel manufacture to be purchased from abroad with foreign currencies. This is obviously too much of a burden for Japan's economy striving to get back on its own feet.

and railroad facilities, property of former Japanese army and navy and some other minor property in use by the Allied Occupation Forces not covered by the present survey.

II. The requirements for various installations and facilities of the Occupation Forces, being presently engaged in operations against the Communist forces in North Korea, would be greater than in normal times. It is requested, however, that, on restoring peaceful relations between the two nations, returning of as many installations and facilities as circumstances may permit be considered, especially private dwellings, educational institutions (see attached Statistical Survey No. 1-D), facilities essential for economic activities, such as pier and warehouse facilities at the ports of Yokohama and Kobe, buildings for commercial use (see attached Statistical Survey No. 1-C) etc.

Foreword

1. The present survey deals only with the installations and facilities under jurisdiction of the Special Procurement Agency used by the occupation forces as of March 31st, 1951. They are broken down into land, building, structure and their accessory movable property with their valuation.

2. In Table 1 and Table 2, the former showing the summary throughout Japan and the latter for jurisdictional area of each of 9 local Special Procurement Bureaus, the installation and facilities are broken down into the following classifications according to owners:

A—Privately-owned real property.

B—Public entity owned real property.

C— Real property owned by the Japanese Government Corporation for Housing of Allied Personnel (abbreviated to J.S. CHAP).

D—State-owned real property acquired or constructed by the Special Procurement Agency, with the Termination of War Fund.

E—State-owned real property acquired or constructed by governmental agencies other than the Special Procurement Agency with the Termination of War Fund.

F—Other state-owned real property.

G.—Real property of former Japanese army or navy.

3. In Table 3 and Table 4, the former likewise showing the summary throughout Japan and the latter for jurisdictional area of the local Bureaus,

the terms as employed in the column of "Use" include respectively the following kind of installations and facilities:

1. Troop Housing—Billeting quarters for officers and men, and facilities annexed thereto such as mess halls, lecture halls, chapels, Pxes, fire-brigade stations, fatigue-duty ground, stockades, boiler-houses, substations, water-works and sewerage, motor pools and all other facilities necessary for the maintenance of officers and men.
2. Residence—Dwelling facilities for officers and men and their dependents, such as houses and annexed pathways, fences, gardens; camps and their annexed facilities (schools, fire-brigade stations, playing fields, boiler-houses etc.) Such utilities commonly used with troop housing facilities as cannot be separately considered are included in troop housing facilities.
3. Aviation Ground—Facilities for landing and taking off, housing and maintenance of aircraft, such as runways, aprons, illumination facilities, direction houses, hangars, maintenance shops etc.
4. Port—Facilities for entry and departure, anchoring, loading and unloading of vessels, such as docks, quays, piers, breakwaters etc.
5. Office—Offices necessary for taking command of forces and their administration and annexed facilities, such as headquarters of above the level of the division, independent headquarters, CIC etc.
6. Manoeuvre Areas—Facilities for manoeuvring officers and men, such as manoeuvre ground and annexed quarters, shooting ranges, training ground etc.
7. Factory—Various factories which exist separately and their annexed facilities.
8. Warehouse & Storage—Facilities for storing sundry materials and commodities, such as warehouses, oil-tanks, out-door piling ground, unpacking spaces etc. Which exist separately.
9. Medical Service—Independent hospitals and their annexed facilities.
10. Education—Independent educational facilities for officers and men.
11. Rest & Recreation—Facilities for trip and recreation for officers and men and their dependents, such as independent hotels, clubs, theaters, golf courses, bathing resorts etc.
12. Telecommunication—Independently existent telecommunication facilities such as radar stations, beacon stations, VHF's, transmitting and receiving stations, light beacons, obstruction lights etc.
13. Transportation—Facilities for land transportation, such as RTO, railway sidings etc.

14. Operation—Various facilities for strategic operations other than aviation grounds and ports.
15. Missions—Offices, official buildings and their annexed facilities of diplomatic and consulate missions.
16. Others—Facilities not mentioned elsewhere.

#### 4. Method of Valuation

##### A. Land

Value of each plot is as of March 31st, 1951 estimated from sales price of the similar kind of land in its neighborhood.

##### B. Building and Structure

Value is as of March 31st, 1951, computed from estimated rebuilding price less depreciation by wear and tear. It does not mean the so-called market price.

Structures located within buildings are included in them in valuation while those outside valued separately, except in case of requisitioned dwelling houses where value of all structures is included in the houses.

##### C. Accessory Movable Property

Their value was computed by multiplying the value at the time of requisitioning by the rate of rise as of March 31st, 1951 with appropriate depreciation by wear and tear. Value on March 31st, 1951 is doubled as against that of June 1st, 1949.

Foreword

This survey deals in detail with principal installations and facilities and buildings in large cities summarized in separate report Statistical Survey No. 1-A. They are arranged in this survey in order of their current value.

The value of each of the installations, facilities and buildings is inclusive of that of their composite land, buildings, structures and their accessory movable property irrespective of the owners—whether private persons, local entities Corporation for the Housing of Allied Personnel or the Government. It should be noted, however, that value of certain composite items under jurisdiction of other agencies than the Special Procurement Agency, such as air navigation facilities under that of the Air Navigation Agency, railway sidings the National Railroad Corporation, is not included here. If included, such total value being increased, the present order of arrangement may have to be changed.

In table 1, facilities are classified by their uses in the order of their value. Dwelling houses, offices, factories, warehouses etc., which are directly annexed to troop housing, aviation ground or port facilities are included therein, while those which are independent are treated separately in the appropriate categories.

Foreword

The present survey deals only with government owned vessels used by the Allied Occupation Forces. Those privately-owned vessels in use by the Occupation Forces are under jurisdiction of the Special Property Section, Maritime Bureau, Transportation Ministry, and are not treated in this survey.

Such Government-owned vessels number 183 in total, amounting to 23,338.54 in tonnage and 609,375,886 yen in value as of March 31st, 1951. No procurement demand is issued in requisitioning on government-owned vessels.

The value of these vessels was obtained by multiplying their value set forth in the "Valuation Standard of Special and Miscellaneous Service Vessels, 1948" of the former Government Property Bureau (currently, Control Bureau), Finance Ministry, which was prepared to set standard for valuation of vessels sold by the Government, by their price indices of October 1949 worked out by the same Ministry and applied as they were at the time of this survey, that is, March 31st, 1951. The fact should be noted, however, that later on May 10th, 1951, their price indices were triplicated on an average as against the time of this survey.

Classification F in the below tables means those vessels used by the Occupation Forces which are owned by the Government except (1) those acquired or built by the Special Procurement Agency with the Termination of War Fund (2) those acquired or built by any governmental agencies other than the Special Procurement Agency with the Termination of War Fund and (3) those formerly belonged to Japanese Army or Navy, while G those referred to in (3) above.

Airfield for Civil Air Navigation

1. Preparations are in progress for the civil air navigation in Japan, on the assumption that it will start as of August 1 this year.
2. The Japanese Government contemplates the establishment of the following eleven routes for domestic air service.

1. Sapporo—Tokyo.
2. Sapporo—Misawa—Sendai—Tokyo.
3. Tokyo—Osaka—Fukuoka.
4. Tokyo—Nagoya—Osaka—Iwakuni—Fukuoka.
5. Tokyo—Niigata.
6. Tokyo—Matsumoto—Komatsu—Osaka.
7. Osaka—Miho—Ozaki—Osaka.
8. Osaka—Takamatsu—Matsuyama—Oita.
9. Osaka—Tokushima—Kochi.
10. Fukuoka—Nagasaki (Omura).
11. Fukuoka—Kumamoto—Kagoshima—Miyazaki—Oita—  
Fukuoka.

3. Of the necessary air fields, Chitose (Hokkaido), Haneda (Tokyo), Itami (Hyogo) and Itasuki (Fukuoka) furnish the four major bases for the operation of Japan's civil air service. Haneda will assume greater importance in the future as an international airport. It is desired that the feasibility will be considered of turning over to the Aeronautical Aids Agency the administration of these four fields as ports for the use of Japanese civil air lines.

Needless to say, these fields will be available at all times for the use of American forces stationed in Japan.

4. In order to operate the above-mentioned eleven routes it will be necessary to use the air fields listed below. Even in case these are placed under the control of the American forces for their use after the conclusion of peace, it is desired that they will be opened to Japanese civil air navigation.

Concerning the Islands to be Placed under Trusteeship.

This is not intended as a request for modification of the principles stipulated in the peace treaty. Only in the hope that those principles may be put in force as smoothly as possible the desiderate of the Japanese government are submitted hereinunder for the consideration of the American government.

The Nansei Archipelago, the Bonins and other islands have always been Japanese territory, inseparably tied to Japan proper; and their inhabitants are Japanese, the same in every respect as those of Japan proper. These islands in this regard differ fundamentally in character from the other areas placed under trusteeship following World War II. It is therefore desired that this special nature of the islands will be born in mind, and that in establishing a trusteeship system the American government will avoid incorporating in the basic instruments, including the trusteeship agreement, any provision that might preclude the realization in future of the Japanese aspirations as set forth below.

(1) Status of the Inhabitants

The Japanese having their homes on these islands today number some 900,000. Practically all of them want to retain their Japanese nationality. And Japan desires to continue to treat these people as Japanese nationals.

Actually, there are about 300,000 people from these islands, who reside in Japan proper, and of whom 100,000 are domiciled therein. These 300,000 people have stayed, without availing themselves of the opportunity offered them to return to their home islands following the war's end, simply because they want to remain as Japanese.

There are also some 50,000 people from these islands, who are now living in third countries. They have gone out as Japanese, and a great majority of them desire to remain Japanese.

(2) Economic Relations

It is desired that the economic bonds that have subsisted hitherto between Japan proper and these islands will not be arbitrarily cut off. Accordingly, it is desired that the trade between Japan proper and these islands be allowed to go on as "frontier trade" free of all custom duties on either side. As far as Japan is concerned, this is the arrangement currently in force



under the Law in effect as from May 1, 1951. (See Note). It is hoped that it will be made a principle not to impose any trade restrictions, and a free movement of capital be permitted as far as possible. It is also desired that the freedom of coastal fishing and the use of coastal fishery bases be mutually recognized, as well as the freedom, in principle, of travel and movements of ships either way.

Note: Supplementary Provision No. 4 of the Law relating to Partial Revision of the Customs Tariff.

“Commodities produced in the Nansei Islands, to which a certificate of origin, as provided for by Cabinet Order, is attached, shall be exempted from import duties for the time being. In the present case, “Nansei Islands” means the Nansei islands south of 30 degrees North Longitude, which are considered foreign territory under Article 12 of the Customs Tariff Law.”

### (8) Cultural Relations

At present these islands are permitted to carry on the education of children according the Japanese school system and curricula with a view to enabling them to enter high schools in Japan proper. It is desired that this education policy will be continued after the establishment of trusteeship, and that Japan proper and these islands be allowed to recognize mutually the corresponding study courses, graduation qualifications, and public examinations of various kinds in connection with advancing to higher institutions or obtaining employment.

### (4) Bonins and Iwojima Resettlement

Some 8,000 inhabitants of the Bonins and Iwojima were forced to evacuate to Japan proper during and after the war. These people have not yet been permitted to return to their home islands. In view of their ardent desire to go back to their native islands, the American government is requested to consider their resettlement at the earliest possible date.

南西諸島、小笠原諸島その他の諸島は、元来日本本土と不可分の一体をなし、住民があらゆる面で日本本土住民と同じ住民である点において、第2次大戦後信託統治の下に置かれた他地域と根本的に異なる性格を有している。故に合衆国において右の諸島に信託統治制を適用されるにあたっては、この特殊性を念頭に置かれて、次に要請されているようなことの実現を将来にわたって封ずるような規定が信託統治条項を含む基本的な関係諸文書に含まれないよう考慮されたい。

### (1) 住民のステイタス

現に、当該諸島に住所を有する者の数は、約90万に達する。これらのほとんどすべては、日本国籍の保有を欲してゐる。(そのためには日本本土に住所を移すことも辞さない気持の者が青年層に多いといわれてゐる。) 故に、日本はこれらの人々を日本人として取扱つて行きたい。

現に、日本本土に住所を有する当該諸島出身者は、約30万に達する。そのうち10万は、戸籍が本土にある。これら約30万の者が終戦後あたえられた帰島の機会を利用することなくふみ止まつているのは、日本人として残ることを希望しているからに外ならない。

現に、当該諸島出身者であつて第3国に在住する者は、約5万に上ると推定される。これらの者は、元来日本人として渡航して行つたものであるのみならず、大部分が引き続き日本人であることを希望していると聞いている。

### (2) 経済関係

これらの諸島と日本本土間に従前存在していた経済関係は、人為的に切斷されぬようにいたしたい。これがため、当該諸島と日本本土間の貿易はいわゆる国境貿易的のものとし、相互になんらの関税を課さないこととしたい。日本に関する限り既に昭和26年5月1日施行の法律(注)によつてそのように処置している。また、その他の貿易統制上の制限をも原則として課さないこととする外、資金の交流についてもできる限り自由にされたい。

又、相互に沿岸漁業に従事し、且つ、沿岸漁業基地を利用することを認めると共に、相互間の人、船舶の往復についても原則として自由とされたい。

るものの輸入税は、当分の間、免除する。この場合において南西諸島とは、関税定率法第12条の規定によつて外国とみなされる北緯30度以南の南西諸島をいう。」

### (3) 文化関係

現在当該諸島における子弟の教育は、将来における日本本土高等諸学校へ進学する場合の便宜を顧慮し、学制、教材等日本本土に準じて施行することを許されている。信託統治制実施後においてもかかる教育方針を継続されると共に、当該諸島と日本本土の相応する学校の修業又は卒業資格及び公の各種資格試験を相互に進学、及び就職上承認し合うようにしたい。

### (4) 小笠原諸島、硫黄島住民の原島復帰

小笠原諸島、硫黄島等の住民で戦争中及び戦後日本内地に強制的に引き揚げさせられた者は約8千名に上り、これらの者の原島復帰はまだ許されていない。彼らは一日も早く祖先の墳墓の地である原島復帰を希んでいるので最も早い機会に右希望の実現方配慮ありたい。

Concerning the Japanese Nationals Detained in Soviet Union and China.

The fate of the Japanese nationals still detained in Soviet territory and China is a matter of profound concern to the Japanese government as well as to their families and friends. Moreover, whether or not the Potsdam Declaration on repatriation of Japanese troops will hold good after the conclusion of peace is a vexing problem. In view of these circumstances, we requested Ambassador Dulles in April last to have the American government consider the feasibility of issuing a declaration to the effect that those Japanese should be returned speedily according to the dictate of humanity.

The Japanese government desires to repeat the request that the American government consider the issuance of such a declaration at the time of the signing of the peace treaty as representing the consensus of all the signatory Powers.

Should an Insurer who is a national of any of the Allied Powers wish to resume his professional activities in Japan and should the value of the guarantee deposits or reserves required to be held as a condition of carrying on business in Japan be found to have decreased as a result of the depreciation or loss of the securities in which they were constituted, the Japanese Government shall accept the securities, for the purpose of compliance with any requirements as to the reconstitution of deposits and reserves, at the value attributed to them by the Japanese Government at the time of their original acceptance in fulfilment of pre-war deposit and reserve requirements.

6. Suggested Voluntary Japanese Declaration.

With respect to the suggested voluntary declaration concerning insurance companies, it is submitted in the interest of the insured that a time limit—say, 18 months—be set for the operation of this special provision.

This declaration appears to be identical in substance to the declaration found in Annex 15 (B) of the Italian Peace Treaty. If so, the following wording of the latter, being much clearer, would be preferable.

“Should an insurer, who is a national of any of the United Nations, wish to resume his professional activities in Italy, and should the value of the guarantee deposits or reserves required to be held as a condition of carrying on business in Italy be found to have decreased as a result of the loss or depreciation of the securities which constituted such deposits or reserves, the Italian Government undertakes to accept, for a period of eighteen months, such securities as still remain as fulfilling any legal requirements in respect of deposits and reserves.

On Resumption of Business by Insurers of Allied Nations

3 July 1951

1. Before the war, an insurer who wished to carry on insurance business in Japan was required to deposit money or national bond (including foreign state bond) equivalent to 150,000 yen in case of a life insurer and 100,000 yen in case of a loss insurer.

The money thus on deposit was subjected to the Enemy Property Custody Law during the war time, while deposited articles were delivered to custodians to be sold out and money derived from such transaction was deposited in the Enemy Property Administration Account of the Yokohama Species Bank (now transferred to the Special Property Administration Account of the Bank of Japan) opened for these insurers.

Those deposits which have not already been returned are to be returned to these insurers.

2. The insurance companies which carried on business in Japan before the war numbered 28 (see note). Of these 28 companies, 23 have already resumed their business, each depositing 10,000,000 yen in accordance with a post-war law of Japan. Five companies have not resumed their business as yet.

3. It does not seem equitable, therefore, to institute a special treatment at this stage as is suggested for the sake of the remaining five companies.

MEMORANDUM

There is given below the text of a suggested statement that might be made by the Japanese Government with respect to fishing matters:

"In order that there shall be no misunderstanding the Japanese Government confirms that Japan's voluntary declaration in respect of fishing conservation contained in the Prime Minister's letter of the 7th February 1951 to Mr. John Foster Dulles, the special representative of the President of the United States, was intended to embrace fishery conservation arrangements in all parts of the world. The Government of Japan will in accordance with the above mentioned letter be prepared, as soon as practicable after restoration to it of full sovereignty, to enter into negotiations with other countries with a view to establishing equitable arrangements for the development and conservation of fisheries which are accessible to the nationals of Japan and such other countries.

The Government of Japan reaffirms that in the meantime it will, as a voluntary act, implying no waiver of its International Rights, prohibit Japanese Nationals and Japanese registered vessels from carrying on fishing operations in presently conserved fisheries in all waters, where arrangements have already been made either by International or Domestic Act, to protect the fisheries from over-harvesting and in which fisheries Japanese Nationals or Japanese registered vessels were not in the year 1940 conducting operations."

先般ダレス特使一行が、ロンドンで、対日講和問題について英国政府当局と折衝の際、英国側は、日本の海洋漁業について大きい関心をもち、本年2月7日付のダレス特使との往復文書の趣旨が、世界の全水域に及ぶものであることを日本側から自発的に明らかにすることを希望した趣で、最近アリソン公使から連絡があつた。

これは、平和条約で漁業問題について制限を設けられないようにするために必要なことであるし、また、いずれにしても、日本の海洋漁業は、今後、こういう心組で進むべきであると思うので、この案のような政府声明を出すことにしたい。

##### MEMORANDUM

Following are comments on Japanese Government's outline of a proposed "Law relating to Compensations for the Loss or Damage of Allied Property in Japan", as modified and expanded in its memorandum of May 31, 1951:

1. Since the Japanese Government is undertaking to compensate only for losses in respect to sequestered property, it is believed unnecessary for the owner to demonstrate that loss occurred "as a result of the war". It is suggested that the phrase "as a result of the war" be eliminated as one of the conditions of compensation, or that the phrase be defined to include loss from natural causes against which the owner could have insured himself and loss resulting from the failure of persons in possession of the property to take proper care.

2. "Allied nationals" should be defined to include corporations or associations wherever incorporated in which Allied Powers held the entire capital, apart from qualifying shares, at the commencement of the war.

3. In regard to compensation for ownership interests, the use of the difference between pre-war and current prices of shares of stock as the measure of compensation for shareholders is not acceptable in view of the general rise of the prices of shares as a consequence of the decline in the purchasing power of the yen.

4. Limitation upon total compensation or the fixing of compensation at anything less than the full extent of the damage is not acceptable.

5. Deduction from compensation for physical improvement made to damaged property is acceptable, but deduction from compensation for one piece of property based on improvement of a second piece of property owned by the same claimant is not acceptable.

It would be appreciated if the Japanese Government, having the foregoing comments in mind, could be prepared to submit a complete text of the proposed legislation for consideration by Minister Allison, who is expected to arrive in Tokyo on June 24, 1951.
