Agenda 2030 and SDG 2: End hunger, achieve food security and improved nutrition and promote sustainable agriculture

**COP 21, Paris Climate Agreement:** <sup>3</sup>/<sub>4</sub> of NDCs refer to measures on agriculture

**Transformation of agriculture:** requires responsible and sustainable investments.

1) Mainstream climatesmart practices in agriculture and food security programs

3) Disseminate the use of practical guidance to operationalize VGGT and CFS-RAI principles (Analytical Framework for responsible Land-Based Agrcultural Investment and OECD-FAO Guidance for responsible Agricultural Supply Chains)
