DESCRIPTION OF REQUIREMENTS

The United Nations intends to engage the services of a qualified vendor for the provision of PV-Diesel Hybrid Power Systems intended for providing power supply to infrastructure and centers located in UN peacekeeping and humanitarian operations.

The scope will include the following requirements:

a. Design, engineering and manufacturing of PV-Diesel Hybrid Power Systems, in line with the technical requirements and performance specifications;

b. Export packaging and shipment of the Photovoltaic (PV) Power Systems components into standard 20 or 40 foot ISO Sea Containers;

c. Export packaging and shipment of spare/miscellaneous parts into standard 20 foot ISO Sea Containers;

d. Provision of after-sale support services (spare parts, training, optional take-back scheme etc.);

The main components of the envisioned PV-Diesel Hybrid Power Systems are:

- 1. PV-Diesel hybrid power systems
- 2. PV panels
- 3. PV supporting structures
- 4. PV inverters (grid-following)
- 5. Bi-directional inverters (battery inverters)
- 6. Energy Storage Systems (ESS)

- 7. Cables and connectors
- 8. Pre-cabled junction boxes, electrical panels
- 9. Grounding and lightning protection
- 10. All other miscellaneous parts

The vendor will be required to demonstrate effective environmental controls and compliance with the relevant legislation and regulations regarding the protection of the environment, labour and human rights.

The goods and services will be provided through a multi-year system contract, and be used worldwide in Peacekeeping Operations, Political Missions and UN Offices.

The detailed scope of requirements will be provided in the Request for Proposal (RFP), which will be sent out to all vendors responding to this EOI. No further detail can be made available prior to the issuance of the RFP solicitation.
