UNDP further partners with African Union/ILO/UNICEF/ and Tony Elumelu Foundation (TEF) on dedicated programmes for youth economic development in Africa. Since 2019 the UNDP/TEF programme built capacities of 4,942 youths and financed startups across the continent.
