

more efficient and effective ODA




#### To <u>ensure public accountability</u> as well as to gain public



# Partner Country-led Evaluation

#### **Objectives:**

- To enhance evaluation capacities of partner countries
- To reflect various viewpoints and ensure objectivity in ODA evaluations

#### **Evaluators:**

- Government officials, academia, experts or consultants of partner countries
- Can be joint evaluation

#### **Evaluation Criteria:**

- Based on OECD-DAC Evaluation Criteria
- Relevance of Policies, Effectiveness of Results, Appropriateness of Processes

## Processes

#### Plan

Choose evaluators and targets

-> Create proposal

#### **Evaluate**

Create evaluation design

- -> Gather and analyze data
- -> Evaluate and make recommendations
- -> Draft evaluation report

#### Publicize

Publicize results on MOFA website

#### Feedback

Provide feedback to stakeholders
