- (2) The payments referred to in subparagraph (1) above will be made when payment requests are presented by the Bank to the Government of Japan under an authorization to pay issued by the Government of Papua New Guinea or its designated authority.

- (a) to ensure prompt unloading and customs clearance at ports of disembarkation in Papua New Guinea and internal transportation therein of the products purchased under the Grant;
- (b) to exempt Japanese nationals from customs duties, internal taxes and other

- fiscal levies which may be imposed in Papua New Guinea with respect to the supply of the products and services under the Verified Contracts;
- (c) to accord Japanese nationals whose services may be required in connection with the supply of the products and services under the Verified Contracts such facilities as may be necessary for their entry into Papua New Guinea and stay therein for the performance of their work;
- (d) to ensure that the products purchased under the Grant be maintained and used properly and effectively for the execution of the Projects; and
- (e) to bear all the expenses, other than those covered by the Grant, necessary for the execution of the Project.
- (2) With regard to the shipping and marine insurance of products purchased under the Grant, the Government of Papua New Guinea will refrain from imposing any restrictions that may hinder fair and free competition among the shipping and marine insurance companies.
- (3) The products purchased under the Grant shall not be re-exported from Papua New Guinea.
