3. (1) The Grant will be used by the

Excellency,

I have the honour to refer to the Exchange of Notes dated November 26, 1990, between the Government of Japan and the Government of Western Samoa concerning Japanese economic cooperation for the execution of the Project for Rehabilitation of Cyclone-damaged Ports and Construction of Quarry Plant (hereinafter referred to as "the Project").

- I have further the honour to refer to the recent discussion held between the representatives of the two Governments concerning additional Japanese economic cooperation to be extended with a view to strengthening friendly and cooperative relations between the two countries, and to propose on behalf of the Government of Japan the following arrangements:
- 1. For the purpose of contributing to the execution of the Project by the Government of Western Samoa, the Government of Japan will extend to the Government of Western Samoa, in accordance with the relevant laws and regulations of Japan, a grant up to six hundred eighty-seven million yen (\footnote{\footn
- 2. The Grant will be made available during the period between the date of coming into force of the present arrangements and March 31, 1992, unless the period is extended by mutual agreement between the authorities concerned of the two Governments.

- Government of Western Samoa properly and exclusively for the purchase of the products of Japan or Western Samoa and the services of Japanese or Western Samoan nationals listed below: (The term nationals whenever used in the present arrangements means Japanese physical persons or Japanese juridical persons controlled by Japanese physical persons in the case of Japanese nationals, and Western Samoan physical or juridical persons in the case of Western Samoan nationals.)
- (a) products and services necessary for rehabilitation of breakwater, marine office, cargo sheds and other related facilities at Apia Port, dredging of channel and rehabilitation of ferry ramp and other related facilities at Mulifanua Port, and rehabilitation of navigation aids at Salelologa and other ports (hereinafter jointly referred to as "the Facilities");
- (b) products and services necessary for repair of the boats; and
- (c) services necessary for the transportation of the products referred to in (a) and (b) above to ports in Western Samoa and those for internal transportation therein.
- (2) Notwithstanding the provisions of sub-paragraph (1) above, when the two Governments deem it necessary, the Grant may be used for the purchase of the products of the kind mentioned in (a) and (b) of sub-paragraph (1) above, which are products of countries other than Japan or Western Samoa and the services of the kind mentioned in (a), (b) and (c) of sub-paragraph (1) above, which are services of nationals of countries other than Japan or Western Samoa.

- 4. The Government of Western Samoa or its designated authority will enter into contracts in Japanese yen with Japanese nationals for the purchase of the products and services referred to in paragraph 3. Such contracts shall be verified by the Government of Japan to be eligible for the Grant.
- 5. (1) The Government of Japan will execute the Grant by making payments in Japanese yen to cover the obligations incurred by the Government of Western Samoa or its designated authority under the contracts verified in accordance with the provisions of paragraph 4 (hereinafter referred to as "the Verified Contracts") to an account to be opened in the name of the Government of Western Samoa in an authorized foreign exchange bank of Japan designated by the Government of Western Samoa or its designated authority (hereinafter referred to as "the Bank").
- (2) The payments referred to in sub-paragraph (1) above will be made when payment requests are presented by the Bank to the Government of Japan under an authorization to pay issued by the Government of Western Samoa or its designated authority.
- (3) The sole purpose of the account referred to in sub-paragraph (1) above is to receive the payments in Japanese yen by the Government of Japan and to pay to the Japanese nationals who are parties to the Verified Contracts. The procedural details concerning the credit to and debit from the account will be agreed upon through consultation between the Bank and the Government of Western Samoa or its designated authority.
- 6. (1) The Government of Western Samoa will take necessary measures:

- (a) to secure lots of land necessary for the construction of the Facilities and to clear the site;
- (b) to provide facilities for distribution of electricity, water supply and drainage and other incidental facilities outside the site;
- (c) to ensure prompt unloading and customs clearance at ports of disembarkation in Western Samoa and internal transportation therein of the products purchased under the Grant;
- (d) to exempt Japanese nationals from customs duties, internal taxes and other fiscal levies which may be imposed in Western Samoa with respect to the supply of the products and services under the Verified Contracts;
- (e) to accord Japanese nationals whose services may be required in connection with the supply of the products and services under the Verified Contracts such facilities as may be necessary for their entry into Western Samoa and stay therein for the performance of their work;
- (f) to ensure that the Facilities constructed and the boats repaired under the Grant be maintained and used properly and effectively for the execution of the Project; and
- (g) to bear all the expenses, other than those covered by the Grant, necessary for the execution of the Project.
- (2) With regard to the shipping and marine insurance of products purchased under the Grant, the Government of Western Samoa will refrain from imposing any restrictions that

may hinder fair and free competition among the shipping and marine insurance companies.

(3) The products purchased under the Grant shall not be re-exported from Western Samoa.

7. The two Governments will consult with each other in respect of any matter that may arise from or in connection with the present arrangements.

I have further the honour to propose that this Note and Your Excellency's Note in reply confirming on behalf of the Government of Western Samoa the foregoing arrangements shall be regarded as constituting an agreement between the two Governments, which will enter into force on the date of Your Excellency's reply.

I avail myself of this opportunity to renew to Your Excellency the assurance of my highest consideration.
