The Government of Japan will execute the Grant by making payment in Japanese yen of the amount referred to in paragraph 1 to the Account during the period between the date of receipt of the written notification referred to in sub-paragraph (1) of paragraph 3 and 31 March, 1994, unless the period is extended by mutual agreement between the authorities concerned of the two Governments.
- 5. (1) The Government of the Union of Myanmar will take necessary measures:
- (a) to use the Grant and its accrued interest within a reasonable period after the Grant is executed;
- (b) to ensure that customs duties, internal taxes and other fiscal levies which may be imposed in the Union of Myanmar with respect to the purchase of the products and services referred to in sub-paragraph (1) of paragraph 2 shall not be borne by the Grant;
- (c) to ensure that the products purchased under the Grant be maintained and used properly and effectively for the development of the economy of the Union of Myanmar and the enhancement of the welfare of its people; and
- (d) to submit to the Government of Japan a report prepared in a written form acceptable to the Government of Japan on the transactions on the Account together with copies of contracts, vouchers and other documents concerning the relevant transactions without delay when the Grant and its accrued interest are completely drawn in accordance with the provisions of

- sub-paragraph (2) of paragraph 3 or upon request by the Government of Japan.
- (2) The products purchased under the Grant shall not be re-exported from the Union of Myanmar.
- 6. The two Governments will consult with each other in respect of any matter that may arise from or in connection with the present arrangements.
- I have further the honour to propose that this Note and Your Excellency's Note in reply confirming on behalf of the Government of the Union of Myanmar the foregoing arrangements shall be regarded as constituting an agreement between the two Governments, which will enter into force on the date of Your Excellency's reply.
