(Japanese Note)

New Delhi, September 30, 1994

Excellency,

I have the honour to refer to the Exchange of Notes dated June 29, 1993, between the Government of Japan and the Royal Government of Bhutan concerning Japanese economic cooperation for the execution of the Paro Valley Agricultural Development Project (hereinafter referred to as "the Project").

I have further the honour to refer to the recent discussions held between the representatives of the two Governments concerning additional Japanese economic cooperation to be extended with a view to strengthening friendly and cooperative relations between the two countries, and to propose on behalf of the Government of Japan the following arrangements:

- 1. For the purpose of contributing further to the execution of the Project by the Royal Government of Bhutan, the Government of Japan will extend to the Royal Government of Bhutan, in accordance with the relevant laws and regulations of Japan, a grant up to seven hundred and sixteen million yen (¥716,000,000) (hereinafter referred to as "the Grant").
- 2. The Grant will be made available during the period between the date of coming into force of the present arrangements and March 31, 1995, unless the period is extended by mutual agreement between the authorities concerned of the two Governments.
- 3. (1) The Grant will be used by the Royal Government of Bhutan properly and exclusively for the purchase of the products of Japan or the Kingdom of Bhutan and the services of Japanese or Bhutanese nationals listed below: (The term nationals whenever used in the present arrangements means Japanese physical persons or Japanese juridical persons controlled by Japanese physical persons in the case of Japanese nationals, and Bhutanese physical or juridical persons in the case of Bhutanese nationals.)
- (a) products and services necessary for the construction of irrigation channels, farm roads and river protection facilities (hereinafter jointly referred to as "the Facilities");

- vehicles, equipment and materials necessary for he execution of the Project and services necessary or the procurement thereof; and
- (c) services necessary for the transportation of the products referred to in (a) and (b) above to the Kingdom of Bhutan and those for internal transportation therein.
- (2) Notwithstanding the provisions of sub-paragraph (1) above, when the two Governments deem it necessary, the Grant may be used for the purchase of the products of the kind mentioned in (a) and (b) of sub-paragraph (1) above, which are products of countries other than Japan or the Kingdom of Bhutan and the services of the kind mentioned in (a), (b) and (c) of sub-paragraph (1) above, which are services of nationals of countries other than Japan or the Kingdom of Bhutan.
- 4. The Royal Government of Bhutan or its designated authority will enter into contracts in Japanese yen with Japanese nationals for the purchase of the products and services referred to in paragraph 3. Such contracts shall be verified by the Government of Japan to be eligible for the Grant.
- 5. (1) The Government of Japan will execute the Grant by making payments in Japanese yen to cover the obligations incurred by the Royal Government of Bhutan or its designated authority under the contracts verified in accordance with the provisions of paragraph 4 (hereinafter referred to as "the Verified Contracts") to an account to be opened in the name of the Royal Government of Bhutan in an authorized foreign exchange bank of Japan designated by the Royal Government of Bhutan or its designated authority (hereinafter referred to as "the Bank").
- (2) The payments referred to in sub-paragraph (1) above will be made when payment requests are presented by the Bank to the Government of Japan under an authorization to pay issued by the Royal Government of Bhutan or its designated authority.
- (3) The sole purpose of the account referred to in sub-paragraph (1) above is to receive the payments in Japanese yen by the Government of Japan and to pay to the Japanese nationals who are parties to the Verified Contracts. The procedural details concerning the credit to and debit from the account will be agreed upon through consultation between the Bank and the Royal Government of Bhutan or its designated authority.

- necessary measures: The Royal Government of Bhutan will take
- (a) to secure lots of land necessary for the construction of the Facilities and to clear the site;
- electricity, water supply and drainage and other incidental facilities outside the site; to provide facilities for distribution of
- of Bhutan and internal transportation therein of the products purchased under the Grant; to ensure prompt customs clearance in the Kingdom
- (d) to exempt Japanese nationals from customs duties, internal taxes and other fiscal levies which may be imposed in the Kingdom of Bhutan with respect to the supply of the products and services under the Verified Contracts;
- such facilities as may be necessary for their entry into the Kingdom of Bhutan and stay therein for the performance of their work; (e) to accord Japanese nationals whose services may be required in connection with the supply of the products and services under the Verified Contracts
- used properly and effectively for the execution of the Project; and (f) to ensure that the Facilities constructed and the products purchased under the Grant be maintained and
- (g) to bear all the expenses, other than those covered by the Grant, necessary for the execution of the Project.
- (2) With regard to the shipping and marine insurance of products purchased under the Grant, the Royal Government of Bhutan will refrain from imposing any restrictions that may hinder fair and free competition among the shipping and marine insurance companies.
- (3) The products purchased under the Grant shall not be re-exported from the Kingdom of Bhutan.
- 7. The two Governments will consult with each other in respect of any matter that may arise from or in connection with the present arrangements.
- I have further the honour to propose that this Note and Your Excellency's Note in reply confirming on behalf of

shall be regarded as constituting an agreement between the two Governments, which will enter into force on the date of the Royal Government of Bhutan the foregoing arrangements Your Excellency's reply.
