Sir,

- I have the honour to refer to the recent discussions held between the representatives of the Government of Japan and of the Government of the Republic of Maldives concerning Japanese economic cooperation to be extended in connection with the Food Aid Convention, 1986, and to propose on behalf of the Government of Japan the following arrangements:
- 1. The Government of Japan will extend to the Government of the Republic of Maldives, in accordance with the relevant laws and regulations of Japan, a grant up to one hundred million yen (¥100,000,000) (hereinafter referred to as "the Grant").
- 2. The Grant will be made available during the period between the date of coming into force of the present arrangements and March 31, 1995, unless the period is extended by mutual agreement between the authorities concerned of the two Governments.
- 3. (1) The Grant will be used by the Government of the Republic of Maldives properly and exclusively for the purchase of the rice and services listed below:
- (a) That rice up to sixty-two million yen (\frac{462}{000},000) F.O.B., and
- (B) services up to thirty-eight million yen (¥38,000,000) necessary for the transportation of the rice referred to in sub-paragraph (a) above from ports in the Kingdom of Thailand to ports in the Republic of Maldives.
- (2) Notwithstanding the provisions of sub-paragraph (1) above, when the two Governments deem it appropriate, a part of the amount referred to in (b) of the said sub-paragraph may be used for the additional purchase of the rice and services necessary for the transportation thereof.
- 4. The Government of the Republic of Maldives or its designated authority will enter into contracts in Japanese yen with Japanese nationals for the purchase of the rice and services referred to in paragraph 3. Such contracts shall be verified by the Government of Japan to be eligible

for the Grant. (The term Japanese nationals whenever used in the present arrangements means Japanese physical persons or Japanese juridical persons controlled by Japanese physical persons.)

- 5. (1) The Government of Japan will execute the Grant by making payments in Japanese yen to cover the obligations incurred by the Government of the Republic of Maldives or its designated authority under the contracts verified in accordance with the provisions of paragraph 4 (hereinafter referred to as "the Verified Contracts") to an account to be opened in the name of the Government of the Republic of Maldives in an authorized foreign exchange bank of Japan designated by the Government of the Republic of Maldives or its designated authority (hereinafter referred to as "the Bank").
- (2) The payments referred to in sub-paragraph (1) above will be made when payment requests are presented by the Bank to the Government of Japan under an authorization to pay issued by the Government of the Republic of Maldives or its designated authority.
- (3) The sole purpose of the account referred to in sub-paragraph (1) above is to receive the payments in Japanese yen by the Government of Japan and to pay to the Japanese nationals who are parties to the Verified Contracts. The procedural details concerning the credit to and debit from the account will be agreed upon through consultation between the Bank and the Government of the Republic of Maldives or its designated authority.
- 6. (1) The Government of the Republic of Maldives will take necessary measures:
- (a) to ensure prompt unloading and customs clearance at ports of disembarkation in the Republic of Maldives and prompt internal transportation therein of the rice purchased under the Grant;
- (b) to meet the charge of customs duties, internal taxes and other fiscal levies which may be imposed in the Republic of Maldives with respect to the supply of the rice and services under the Verified Contracts;
- (c) to ensure that the rice purchased under the Grant will make effective contribution to the stabilizing and development of the Maldivian economy; and
- (d) to bear all the expenses, other than those to be borne by the Grant, necessary for the execution of the
