I have the honour to refer to the recent discussions held between the representatives of the Government of Japan and of the Government of the Democratic Socialist Republic of Sri Lanka concerning Japanese economic cooperation to be extended with a view to strengthening friendly and cooperative relations between the two countries, and to propose on behalf of the Government of Japan the following arrangements:

- 1. For the purpose of contributing to the execution of the Project for the Improvement of the Rural Infrastructure in Walawe Left Bank Area (hereinafter referred to as "the Project") by the Government of the Democratic Socialist Republic of Sri Lanka, the Government of Japan will extend to the Government of the Democratic Socialist Republic of Sri Lanka, in accordance with the relevant laws and regulations of Japan, a grant up to nine hundred sixtyeight million yen (#968,000,000) (hereinafter referred to as "the Grant").
- 2. The Grant will be made available during the period between the date of coming into force of the present arrangements and January 20, 1995, unless the period is extended by mutual agreement between the authorities concerned of the two Governments.
- 3. (1) The Grant will be used by the Government of the Democratic Socialist Republic of Sri Lanka properly and exclusively for the purchase of the products of Japan or Sri Lanka and the services of Japanese or Sri Lankan nationals listed below: (The term nationals whenever used in the present arrangements means Japanese physical persons or Japanese juridical persons controlled by Japanese physical persons in the case of Japanese nationals, and Sri Lankan physical or juridical persons in the case of Sri Lankan nationals.)
- (a) products and services necessary for the construction of water supply facilities and the rehabilitation of main rural road and related facilities (hereinafter jointly referred to as "the Facilities");
- (b) equipment necessary for the execution of the

project and services necessary for the procurement thereof; and

- (c) services necessary for the transportation of the products referred to in (a) and (b) above to ports in the Democratic Socialist Republic of Sri Lanka, and those for internal transportation therein.
- (2) Notwithstanding the provisions of sub-paragraph (1) above, when the two Governments deem it necessary, the Grant may be used for the purchase of the products of the kind mentioned in (a) and (b) of sub-paragraph (1) above, which are products of countries other than Japan or Sri Lanka and the services of the kind mentioned in (a), (b) and (c) of sub-paragraph (1) above, which are services of nationals of countries other than Japan or Sri Lanka.
- 4. The Government of the Democratic Socialist Republic of Sri Lanka or its designated authority will enter into contracts in Japanese yen with Japanese nationals for the purchase of the products and services referred to in paragraph 3. Such contracts shall be verified by the Government of Japan to be eligible for the Grant.
- making payments in Japanese yen to cover the obligations incurred by the Government of the Democratic Socialist Republic of Sri Lanka or its designated authority under the contracts verified in accordance with the provisions of paragraph 4 (hereinafter referred to as "the Verified Contracts") to an account to be opened in the name of the Government of the Democratic Socialist Republic of Sri Lanka in an authorized foreign exchange bank of Japan designated by the Government of the Democratic Socialist Republic of Sri Lanka or its designated authority (hereinafter referred to as "the Bank").
- (2) The payments referred to in sub-paragraph (1) above will be made when payment requests are presented by the Bank to the Government of Japan under an authorization to pay issued by the Government of the Democratic Socialist Republic of Sri Lanka or its designated authority.
- (3) The sole purpose of the account referred to in sub-paragraph (1) above is to receive the payments in Japanese yen by the Government of Japan and to pay to the Japanese nationals who are parties to the Verified Contracts. The procedural details concerning the credit to and debit from the account will be agreed upon through consultation between the Bank and the Government of the Democratic Socialist Republic of Sri Lanka or its

designated authority.

- 6. (1) The Government of the Democratic Socialis Republic of Sri Lanka will take necessary measures: The Government of the Democratic Socialist
- (a) to secure a lot of land necessary for the construction of the Facilities and to clear the site;
- electricity, water supply, drainage and other incidental facilities outside the site; to provide facilities for distribution of
- at ports of disembarkation in the Democratic Socialist Republic of Sri Lanka and internal transportation therein of the products purchased under the Grant; to ensure prompt unloading and customs clearance
- Lanka with respect to the supply of the products and services under the Verified Contracts; (d) to exempt Japanese nationals from customs duties, internal taxes and other fiscal levies which may be imposed in the Democratic Socialist Republic of Sri
