Excellency,

I have the honour to refer to the recent discussions held between the representatives of the Government of Japan and of the Government of the Republic of the Philippines concerning Japanese economic cooperation to be extended with a view to strengthening friendly and cooperative relations between the two countries, and to propose on behalf of the Government of Japan the following arrangements:

- 1. For the purpose of contributing to the increase of food production in the Republic of the Philippines, the Government of Japan will extend to the Government of the Republic of the Philippines, in accordance with the relevant laws and regulations of Japan, a grant up to one billion seven hundred and fifty million yen (¥1,750,000,000) (hereinafter referred to as "the Grant").
- 2. The Grant will be made available during the period between the date of coming into force of the present arrangements and March 31, 2000, unless the period is extended by mutual agreement between the authorities concerned of the two Governments.
- 3. (1) The Grant will be used by the Government of the Republic of the Philippines properly and exclusively for the purchase of the products of Japan and the services listed below:
- (a) for the Philippine-Japan Food Production Programme, up to one billion seventy million yen (¥1,070,000,000):
- i) fertilizer and services relating to the procurement thereof; and
- (ii) services necessary for the transportation of the products referred to in (i) above to ports in the Republic of the Philippines;
- (b) for the projects for which the Asian Development Bank extends financial assistance, up to one hundred and eighty million yen (#180,000,000):
- fertilizer and services relating to the

## procurement thereof; and

- (ii) services necessary for the transportation of the products referred to in (i) above to ports in the Republic of the Philippines; and
- (c) for the Integrated Food Security Programs for Drought Victims in Mindanao, up to five hundred million yen (\pmu500,000,000):
- (i) fertilizer, agricultural chemicals, agricultural machinery and equipment, vehicles for transportation and services relating to the procurement thereof; and
   ii) services necessary for the transportation of the products referred to in (i) above to
- ports in the Republic of the Philippines.

  (2) Notwithstanding the provisions of sub-paragraph
  (1) above, when the two Governments deem it necessary, the
  Grant may be used for the purchase of the products of the
  kind mentioned in (a)(i), (b)(i) and (c)(i) of subparagraph (1) above, which are products of eligible source
  countries other than Japan.
- 4. The Government of the Republic of the Philippines or its designated authority will enter into contracts in Japanese yen with Japanese nationals for the purchase of the products and services referred to in paragraph 3. Such contracts shall be verified by the Government of Japan to be eligible for the Grant. (The term "Japanese nationals" whenever used in the present arrangements means Japanese physical persons or Japanese juridical persons controlled by Japanese physical persons.)
- 5. (1) The Government of Japan will execute the Grant by making payments in Japanese yen to cover the obligations incurred by the Government of the Republic of the Philippines or its designated authority under the contracts verified in accordance with the provisions of paragraph 4 (hereinafter referred to as "the Verified Contracts") to an account to be opened in the name of the Government of the Republic of the Philippines in a bank of Japan designated by the Government of the Republic of the Philippines in a bank of Japan designated designated authority (hereinafter referred to as "the Bank").
- (2) The payments referred to in sub-paragraph (1) above will be made when payment requests are presented by

the Bank to the Government of Japan under an authorization to pay issued by the Government of the Republic of the Philippines or its designated authority.
