## (Japanese Note)

Hanoi, May 3, 1999

excellency,

I have the honour to refer to the Exchange of Notes dated February 23, 1999, between the Government of Japan and the Government of the Sociallist Republic of Viet Nam concerning Japanese economic cooperation for the execution of the project for Expansion of Water Supply System in Hai Duong City (hereinafter referred to as "the Project").

I have further the honour to refer to the recent discussions held between the representatives of the two Governments concerning additional Japanese economic cooperation to be extended with a view to strengthening friendly and cooperative relations between the two countries, and to propose on behalf of the Government of Japan the following arrangements:

- 1. For the purpose of contributing further to the excution of the Project by the Government of Excialist Republic of Viet Nam, the Government of Japan will extend to the Government of the Socialist Republic of Viet Nam, in accordance with the relevant laws and regulations of Japan, a grant up to two billion eight hundred and twenty-six million yen (#2,826,000,000) (hereinafter referred to as "the Grant").
- 2. The Grant will, in accordance with the relevant laws and regulations of Japan, be made available during each of the following periods within the limit of the corresponding amount for each term, unless such period is extended by mutual agreement between the authorities concerned of the two Governments:
- 1) term I

period between the date of coming into force of the present arrangements and March 31, 2000;

six hundred and fifty-one million yen (\$651,000,000).

(2) term II

period between April 1, 2000 and March 31, 2001;

one billion five hundred and seventy-five million yen (\$1,575,000,000).

(3) to

period between April 1, 2001 and March 31, 2002;

six hundred million yen (¥600,000,000).

- (1) The Grant will be used by the Government of the Socialist Republic of Viet Nam properly and exclusively for the purchase of the products of Japan or the Socialist Republic of Viet Nam and the services of Japanese or Vietnamese nationals listed below: (The term "nationals" whenever used in the present arrangements means Japanese physical persons or Japanese juridical persons controlled by Japanese physical persons in the case of Japanese nationals, and Vietnamese physical or juridical persons in the case of Vietnamese nationals.)
- (a) products and services necessary for the construction of water supply facilities (hereinafter referred to as "the Facilities";
- (b) equipment necessary for the execution of the Project and services necessary for the installation thereof;
- (c) a vehicle necessary for the execution of the Project and services necessary for the procurement thereof; and
- (d) services necessary for the transportation of the products referred to in (a), (b) and (c) above to ports in the Socialist Republic of Viet Nam, and those for internal transportation therein.
- (2) Notwithstanding the provisions of sub-paragraph (1) above, when the two Governments deem it necessary, the Grant may be used for the purchase of the products of the kind mentioned in (a), (b) and (c) of sub-paragraph (1) above, which are products of countries other than Japan or the Socialist Republic of Viet Nam and the services of the kind mentioned in (a), (b), (c) and (d) of sub-paragraph (1) above, which are services of nationals of countries other than Japan or the Socialist Republic of Viet Nam.
- 4. The Government of the Socialist Republic of Viet Nam or its designated authority will enter into contracts in Japanese yen with Japanese nationals for the purchase of

the products and services referred to in paragraph 3. contracts shall be verified by the Government of Japan be eligible for the Grant. ξ
