(Japanese Note)

Dhaka, November 12, 2001

Sir,

I have the honour to refer to the recent discussions held between the representatives of the Government of Japan and of the Government of the People's Republic of Bangladesh concerning Japanese economic cooperation to be extended with a view to strengthening friendly and cooperative relations between the two countries, and to propose on behalf of the Government of Japan the following arrangements:

1. For the purpose of contributing to the execution of the project for Human Resource Development Scholarship (hereinafter referred to as "the Project") by the Government of the People's Republic of Bangladesh, the Government of Japan will extend to the Government of the People's Republic of Bangladesh, in accordance with the relevant laws and regulations of Japan, a grant up to two hundred and ninety-two million yen (¥292,000,000) (hereinafter referred to as "the Grant").
2. The Grant will be made available during the period between the date of coming into force of the present arrangements and November 11, 2002, unless the period is extended by mutual agreement between the authorities concerned of the two Governments.
3. The Grant will be used by the Government of the People's Republic of Bangladesh properly and exclusively for the purchase of the services necessary arrangements to provide academic opportunities for Bangladesh students to study in Japanese higher educational institutions and for providing the said students with necessary expenses for them to study in Japan.
4. The Government of the People's Republic of Bangladesh or its designated authority will enter into a contract in Japanese yen with a Japanese nationals for the purchase of the services referred to in paragraph 3 including transferring of the expenses provided by the Government of the People's Republic of Bangladesh to the said students referred to in the same paragraph. Such contract shall be verified by the Government of Japan to be eligible for the Grant. (The term "Japanese national" whenever used in the present arrangements means Japanese physical person or Japanese juridical person controlled by Japanese physical persons.)

5. (1) The Government of Japan will execute the Grant by making payments in Japanese yen to cover the obligations incurred by the Government of the People's Republic of Bangladesh or its designated authority under the contract verified in accordance with the provisions of paragraph 4 (hereinafter referred to as "the Verified Contract") to an account to be opened in the name of the Government of the People's Republic of Bangladesh in a bank of Japan designated by the Government of the People's Republic of Bangladesh or its designated authority (hereinafter referred to as "the Bank").

(2) The payments referred to in sub-paragraph (1) above will be made when payment requests are presented by the Bank to the Government of Japan under an authorization to pay issued by the Government of the People's Republic of Bangladesh or its designated authority.

(3) The sole purpose of the account referred to in sub-paragraph (1) above is to receive the payments in Japanese yen by the Government of Japan and to pay to the Japanese nationals who is a party to the Verified Contract. The procedural details concerning the credit to and debit from the account will be agreed upon through consultation between the Bank and the Government of the People's Republic of Bangladesh or its designated authority.

6. The Government of the People's Republic of Bangladesh will take necessary measures:

- (a) to exempt Japanese nationals from customs duties, internal taxes and other fiscal levies which may be imposed in the People's Republic of Bangladesh with respect to the supply of the services under the Verified Contract;
- (b) to accord Japanese nationals whose services may be required in connection with the supply of the services under the Verified Contract such facilities as may be necessary for their entry into the People's Republic of Bangladesh and stay therein for the performance of their work;
- (c) to ensure that the services referred to in paragraph 3 be carried out properly and effectively for the execution of the Project; and
- (d) to bear all the expenses, other than those covered by the Grant, necessary for the execution of the Project.

7. The two Governments will consult with each other in respect of any matter that may arise from or in connection with the present arrangements.

I have further the honour to propose that this Note and your Note in reply confirming on behalf of the Government of the People's Republic of Bangladesh the foregoing arrangements shall be regarded as constituting an agreement between the two Governments, which will enter into force on the date of your reply.

I avail myself of this opportunity to renew to you the assurance of my high consideration.
