- 1. For the purpose of contributing to the execution of the project for Rural Electrification for Asesewa and Yeji area (hereinafter referred to as "the Project") by the Government of the Republic of Ghana, the Government of Japan will extend to the Government of the Republic of Ghana, in accordance with the relevant laws and regulations of Japan, a grant up to five hundred and seven million yen (\frac{\pi}{5}07,000,000) (hereinafter referred to as "the Grant").
- 2. The Grant will be made available during the period between the date of coming into force of the present arrangements and March 31, 1997, unless the period is extended by mutual agreement between the authorities concerned of the two Governments.
- 3. (1) The Grant will be used by the Government of the Republic of Ghana properly and exclusively for the purchase of the products of Japan or the Republic of Ghana and the services of Japanese or Ghanaian nationals listed below: juridical persons controlled by Japanese physical persons in the case of Japanese nationals, and Ghanaian physical or arrangements means Japanese physical persons or Japanese juridical persons in the case of Ghanaian nationals.) (The term nationals whenever used in the present
- facilities (hereinafter jointly referred to as "the Facilities"); (a) products and services necessary for the construction of power line and other related

- (3) The sole purpose of the account referred to in sub-paragraph (1) above is to receive the payments in Japanese yen by the Government of Japan and to pay to the Japanese nationals who are parties to the Verified Contracts. The procedural details concerning the credit to and debit from the account will be agreed upon through Republic of Ghana or its designated authority. consultation between the Bank and the Government of the

- 6. (1) The Government of the Republic of Ghana will take necessary measures:
- (a) to secure lots of land necessary for the construction of the Facilities and to clear the sites;
- (b) to provide facilities for distribution of electricity, water supply and drainage and other incidental facilities outside the sites;
- (c) to ensure prompt unloading and customs clearance at ports of disembarkation in the Republic of Ghana and internal transportation therein of the products purchased under the Grant;
- (d) to exempt Japanese nationals from customs duties, internal taxes and other fiscal levies which may be imposed in the Republic of Ghana with respect to the supply of the products and services under the Verified Contracts;
- (e) to accord Japanese nationals whose services may be required in connection with the supply of the products and services under the Verified Contracts such facilities as may be necessary for their entry into the Republic of Ghana and stay therein for the performance of their work;
- (f) to ensure that the Facilities constructed and the products purchased under the Grant be maintained and used properly and effectively for the execution of the Project; and
- (g) to bear all the expenses, other than those covered by the Grant, necessary for the execution of the project.
- (2) With regard to the shipping and marine insurance of products purchased under the Grant, the Government of the Republic of Ghana will refrain from imposing any restrictions that may hinder fair and free competition among the shipping and marine insurance companies.
- (3) The products purchased under the Grant shall not be re-exported from the Republic of Ghana.
- 7. The two Governments will consult with each other in respect of any matter that may arise from or in connection with the present arrangements.
- I have further the honour to propose that this Note and Your Excellency's Note in reply confirming on behalf of

the Government of the Republic of Ghana the foregoing arrangements shall be regarded as constituting an agreement between the two Governments, which will enter into force on the date of Your Excellency's reply.
