- (2) With regard to the shipping and marine insurance of products purchased under the Grant, the Government of Bosnia and Herzegovina will refrain from imposing any restrictions that may hinder fair and free competition among the shipping and marine insurance companies.
- (3) The products purchased under the Grant shall not be re-exported from Bosnia and Herzegovina.
- 7. (1) The Government of Bosnia and Herzegovina will deposit in Bosnian currency an amount equivalent to the yen disbursement paid with respect to the purchase of the products referred to in (a) and (b) of sub-paragraph (1) of paragraph 3 in an account to be opened in its name in the National Bank of Bosnia and Herzegovina. The deposit shall be made within the period of four years from the date of coming into force of the present arrangements, unless otherwise agreed between the authorities concerned of the two Governments.
- (2) The currency thus deposited shall be utilized for the purposes of economic and social development, including agricultural, forestry and/or fisheries development, and the increase of food production in Bosnia and Herzegovina.
- (3) The authorities concerned of the two Governments will consult with each other about the utilization of the currency deposited.
- 8. Further procedural details for the implementation of the present arrangements will be agreed upon through consultation between the authorities concerned of the two Governments.
- 9. The two Governments will consult with each other in respect of any matter that may arise from or in connection with the present arrangements.
- I have further the honour to propose that this Note and Your Excellency's Note in reply confirming on behalf of the Government of Bosnia and Herzegovina the foregoing arrangements shall be regarded as constituting an agreement between the two Governments, which will enter into force on the date of Your Excellency's reply.
