## (Japanese Note)

Excellency,

economic cooperation for the execution of the project for Rehabilitation of the National Roads Route 6 and 7 (hereinafter referred to as "the Project"). dated November 29, 1996, between the Government of Japan and the Royal Government of Cambodia concerning Japanese I have the honour to refer to the Exchange of Notes

friendly and cooperative relations between the two countries, and to propose on behalf of the Government of Japan the following arrangements: cooperation to be extended with a view to strengthening Governments concerning additional Japanese economic discussions held between the representatives of the two I have further the honour to refer to the recent

- 1. For the purpose of contributing further to the execution of the Project by the Royal Government of Cambodia, the Government of Japan will extend to the Royal Government of Cambodia, in accordance with the relevant laws and regulations of Japan, a grant up to three billion six hundred and thirty-four million yen (¥3,634,000,000) (hereinafter referred to as "the Grant").

- (2) The payments referred to in sub-paragraph (1) above will be made when payment requests are presented by the Bank to the Government of Japan under an authorization to pay issued by the Royal Government of Cambodia or its designated authority.
- (3) The sole purpose of the account referred to in sub-paragraph (1) above is to receive the payments in Japanese yen by the Government of Japan and to pay to the Japanese nationals who are parties to the Verified Contracts. The procedural details concerning the credit to and debit from the account will be agreed upon through consultation between the Bank and the Royal Government of Cambodia or its designated authority.
- 6. (1) The Royal Government of Cambodia will take necessary measures:
- (a) to secure lots of land necessary for the rehabilitation of the Roads and to clear the site;
- (b) to provide facilities for distribution of electricity, water supply and drainage and other incidental facilities outside the site;
- (c) to ensure prompt unloading and customs clearance at ports of disembarkation in the Kingdom of Cambodia and internal transportation therein of the products purchased under the Grant;
- (d) to exempt Japanese nationals from customs duties, internal taxes and other fiscal levies which may be imposed in the Kingdom of Cambodia with respect to the supply of the products and services under the Verified Contracts;
- (e) to accord Japanese nationals whose services may be required in connection with the supply of the products and services under the Verified Contracts such facilities as may be necessary for their entry into the Kingdom of Cambodia and stay therein for the performance of their work;
- (f) to ensure that the Roads rehabilitated under the Grant be maintained and used properly and effectively for the execution of the Project; and
- (g) to bear all the expenses, other than those

- covered by the Grant, necessary for the execution of the Project.
- (2) With regard to the shipping and marine insurance of products purchased under the Grant, the Royal Government of Cambodia will refrain from imposing any restrictions that may hinder fair and free competition among the shipping and marine insurance companies.
- (3) The products purchased under the Grant shall not be re-exported from the Kingdom of Cambodia.
- 7. The two Governments will consult with each other in respect of any matter that may arise from or in connection with the present arrangements.
- I have further the honour to propose that this Note and Your Excellency's Note in reply confirming on behalf of the Royal Government of Cambodia the foregoing arrangements shall be regarded as constituting an agreement between the two Governments, which will enter into force on the date of Your Excellency's reply.
