The importance of information sharing

Actual situation of system information in The Asia – Pacific Region

Except developed country like Japan, Korea, almost the developing countries in the Asia – Pacific is facing the below problems:

- ❑ Imperfect informative system
- ❑ Methods of collecting information aren't rational.
- ❑ Informative channels aren't correct.



Actual situation of public information in The Asia – Pacific Region

- ❑ Sometime information which was made public had been interfered by Government or leader of countries.
- ❑ Capacity of staff on information management is limited.



Causes

The above shortcomings exist by:

- ❑ Historical process of information's management. Lack of institutions and guidance on information's management in systematic manner
- Weakness in data provision and collection
- The requirement for adjustment of organization, functions and responsibilities of agencies at different level
- Proficiency and capacity of government staff
- Constraints of resources: requirement of high technology in information management, and maintain them must be implemented by various channels and very costly



The Role of information's system at national level

- In context of establishing of social-economic development strategy, vision and orientation:
Good information, with limited resource and so much objectives want to achieved, will be identify strategy, orientation suitable by priorities for maximized effectiveness of using resources, and corresponding of requirement of social-economic development of country, avoid wasteful resources.



The Role of information management at national level

- In results-based management of sustainable growth:
Good information:
 - **Policy:** could help Government have right information of implementation of objectives of strategy and orientation; to know thoroughly which objective or implementation isn't appropriate, the cause why can't reach objective as assigned; timely adjust objective or resource appropriate.
 - **Risk** – timely find potential risk => reduce the risk (if having) and improve effectiveness of using resources of countries.



The importance of information sharing for Effective Risk Management in Asia-Pacific


- In context of globalization
- Widely international economic integration
- increasingly dependent between countries
(impact of financial crisis in 1997-1997;
impact of FDI, export-import)

=> sharing information become more
importance than before.



The importance of information sharing for Effective Risk Management in Asia-Pacific

- Having a good system of information sharing could provide known economic situations in different countries, which helps study good practices to apply in our countries or provide warnings of difficulties, dangers which we may face.
- Immediately learn the impact of application of failure policies to the countries => reduce risk.
- Realizing potential risk on management of social-economic development.




Requirement of improvement of informative system of developing countries in Asia-Pacific
