2.1 Overview of FY2014 ODA Evaluation

Chapter 2 provides an overview of ODA evaluations conducted by MOFA, other ministries and agencies, JICA, and partner country, mainly in FY2014.


Evaluations by MOFA

MOFA implemented nine third-party ODA evaluations in FY2014 that it commissioned to external experts. This chapter provides an overview of these evaluations and presents MOFA's response measures (as of July 2015) to the recommendations derived from these evaluations.

As can be seen in the results of the Country Assistance Evaluation of Kenya, which comments, "Significant effects were ascertained in nearly all of the priority sectors for Japan's ODA to Kenya, therefore, the effectiveness of results is rated high," and the Evaluation of Cooperation for Legal and Judicial Reform, which comments, "Cooperation for legal and judicial reform has contributed greatly to Japan's diplomacy. The evaluation team evaluates highly of the fact that many of those who have become fond of and knowledgeable about Japan through the cooperation, characterized by active interaction at the personal level, have become central figures in the administration and in the business circles," Japan's assistance is desirable in terms of effectiveness and diplomatic impact. At the same time, as can be seen in the results of the Evaluation of the JICA Partnership Program, which comments, "There is room for improvement in some areas to facilitate better operation of the scheme as it was confirmed that local public relations activities were not enough since the project was implemented with limited manpower," some points for improvement of this assistance are presented. Operations Evaluations by JICA

JICA conducts project evaluations of individual projects, as well as thematic evaluations which analyze multiple projects from comprehensive and cross-sectoral perspectives. In FY2013, JICA conducted 76 external ex-post evaluations by third-party evaluators, 50 internal ex-post evaluations, mainly by JICA overseas offices, and 3 thematic evaluations. Evaluations by Other Ministries and Agencies in Japan
